Founded in 1949 as a 10-bed program for homeless, alcoholic men, Harbor Light had an annual budget of \$11,000. Today, with a budget in excess of \$9M, Harbor Light is a multi-service campus that provides the following programs and services to the community:

- **Emergency Shelter Services for Families**
- **Transitional Housing Programs for Men**
- **Community Corrections & Electronic Monitoring Services**
- **Substance Abuse Treatment (medically supervised) & Intensive Outpatient Treatment**
- **A canteen that distributes meals/snacks to the homeless, five (5) days a week**
- **Faith-Based Enrichment & Support through the New Hope Corps (Salvation Army Church)**

**Program success rates:**

- **Alcohol Drug Addiction Services** – Approximately 75% of clients move on to the next level of care. The national average is 50%.
- **P.A.S.S. Program** – More than 73% of men obtain permanent housing, about 50% secure jobs. Housing and Urban Development (HUD) expectations for transitional housing is 71%.
- **Community Corrections Program** – 70% of the clients secure employment, 79% successfully complete the program. The average for successful completions in the State of Ohio is 69%.
- **Electronic Monitoring** – 70% of clients complete the program. The entire State of Ohio averages 58%.
- **Zelma George Family Emergency Shelter** – 72% of families achieve residential stability. Housing and Urban Development (HUD) expectations for transitional housing is 61%.
- **Community Corrections Program (2<sup>nd</sup> floor)** – Approximately 88% of the clients successfully complete the program.

## The Salvation Army Harbor Light Complex

In existence for over 65 years, the Harbor Light Complex (HLC) has been a beacon of hope and help, providing services to the most disenfranchised members of society including homeless men, women and children, the alcoholic, the drug addict and the felon.

### SHELTER SERVICES

#### ***The Zelma George Family Emergency Shelter (ZG)***

- The shelter can accommodate approximately 110 individuals/35 families. It accepts intact families as well as single mothers or fathers with legal custody of their children. It provides 40% of available beds within Cuyahoga County.
- The shelter relocated out of the Harbor Light Complex into a brand new facility adjacent to HLC in November 2016.
- The Zelma George Shelter features large bedrooms, each with a private bathroom, a sizable dining room, a computer lab, laundry facilities, activity rooms and several bright and airy common areas.
- Case managers and a housing specialist assist with various supportive services as well as provide referrals.
- The length of stay is around 3 to 6 months, with most families moving into permanent housing.

#### ***P.A.S.S. Program***

- The Pick Up, Assessment, Shelter & Services program was developed to assist homeless men. It is currently the only HUD funded program/service of its type in Cuyahoga County.
- The program accommodates 75 men and serves as a relief valve for the men's emergency shelter as well as a direct link to CMHA housing.
- Case managers work with each client to increase training/abilities, access community and government resources, develop life-changing skills, and provide assistance with securing employment and housing.

### COMMUNITY CORRECTIONS

#### ***Halfway House, Community Residential Center, Treatment Transfer & Electronic Monitoring***

- By far the largest HLC program with approximately 400 clients, The Ohio Department of Rehabilitation and Correction licenses Harbor Light to supervise the effective transition of both male and female ex-offenders from penal institutions back into the community.
- Upon completion of the orientation period, caseworkers monitor a client's progress within the program and assist with securing such things as a GED, vocational training, referrals to community agencies/services and gainful employment.
- HLC's **Community Residential Center (CRC)** serves as a residence facility for a number of different classes of offenders, most of whom are low-need individuals and pose low to medium risk to reoffend. CRCs are generally intended as an alternative to confinement for persons not suited for probation or for those who need a period of readjustment to the community after imprisonment. It can be argued that CRCs are more humane than prisons and can serve to lessen the deprivations of incarceration. - For many of the clients their criminal behavior is linked to alcohol and/or drug abuse. Clients in the **Treatment Transfer** program are given the opportunity to address the multifaceted challenges of addiction and recidivism through participation in cognitive behavior remediation sessions, music therapy classes, AA meetings, discussion groups, life skills workshops and optional faith-based programming.
- **Electronic Monitoring** affords clients the ability to reside at an approved location outside of HLC while maintaining employment and reporting to their Probation Officer. HLC is currently monitoring over 100 individuals.
- Depending on the program a client is in, their involvement is between 43 days and one (1) year.

### SUBSTANCE ABUSE SERVICES

#### ***Detoxification Unit & Intensive Outpatient Treatment Program***

- Certified by the Ohio Department of Mental Health and Addiction Services, Harbor Light's sub-acute detoxification unit and intensive outpatient program offer exceptional clinical care at a fraction of the cost of hospital or clinic treatment.
- Upon successfully completing **detoxification** (anywhere from 3 to 5 days), **HLC clients** return to their respective program; while all others are most often transferred to a 90-day residential treatment program.
- The intensive outpatient program is available to both HLC clients as well as to those mandated by the Court. Upon completing a preliminary assessment, individuals attend one-on-one counseling sessions and group therapy meetings. Clients participate in the intensive outpatient program for 5 weeks, 3 times per week.

#### ***VIVITROL Injections***

- In an effort to stem the tide in the alarming increase of opiates/heroin addiction, HLC was the first in Cuyahoga County to offer VIVITROL to both its clients as well as community referrals. VIVITROL is a once-monthly, non-addictive medication that prevents an individual from getting high off of opiates/heroin by effectively blocking the corresponding receptors in the brain. Every month, approximately 150 clients and referrals are receiving the injection.
